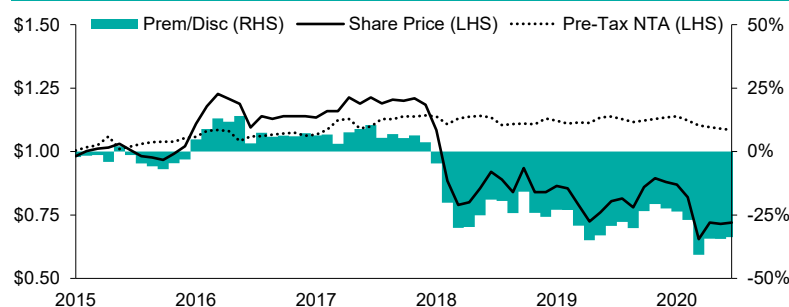

Strong tailwinds in Blue Sky

The Board of **Blue Sky Alternatives Access Fund Limited (BAF)** announced it has entered into a deed of termination with the current investment manager **BSAAF Management Pty Ltd (BSAAF)**. The update from the LIC on 16 July states that the process of appointing **Wilson Asset Management (International) Pty Ltd (WAMI)** as the new investment manager has begun. The termination of the current management services agreement and transition to WAMI is still subject to several conditions. These include the waiver of certain estimated, but not yet payable performance fees. The Board has also further agreed not to request redemption of BAF's current investment in the Argyle Water Fund for a 1 year period. At the end of June, BAF had a direct investment in Argyle Water Fund equal to 26.1% of the portfolio and an indirect exposure of an additional 6.4% via the Strategic Australian Agriculture Fund. An extraordinary general meeting (EGM) is expected to be held in September 2020 where shareholders will be asked to vote on the proposal.

The past issues of BAF and the previous management have been well publicised. The LIC has traded at an average discount to the pre-tax NTA of ~27% since a Glaucus Research Group short report on the Manager **Blue Sky Alternative Investments Limited (BLA)** was released in March 2018. BAF finished FY20 trading at a 33.7% discount, the third widest discount amongst LIC/LITs under Bell Potter coverage.

Figure 1 - BAF 5-year premium/discount



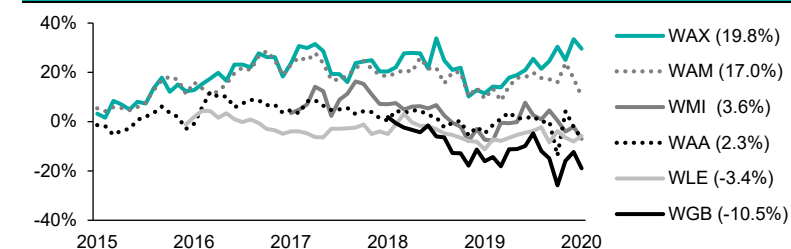

WAMI has a strong investment performance history across 6 current LIC mandates and manages over \$3bn on behalf of more than 85,000 retail investors. The Manager, led by Geoff Wilson, is one of the leaders in managing the listed component of being a closed-end investment vehicle with a number of its LICs trading at a premium to the underlying NTA.

A WAM Alternatives Assets name change can leverage off WAMI's market reputation and focus on a future of higher corporate governance and increased investor relations. Marketing to the existing WAMI retail clients the diversification benefits of gaining portfolio exposure to alternative assets has the ability to increase the on-market demand for the LIC and build a share registry of long-term investors. An experienced investment team would allow for a potential overhaul of parts of the current BAF portfolio. Lead Portfolio Manager Adrian Siew has over 20 years' experience in investment markets, specialising in private equity and alternative asset classes. Previous announcements suggest that WAMI would aim to expand the mandate to allocate the portfolio across select alternative asset managers and add private market investment classes, including debt and infrastructure. A more efficient allocation of capital would drive the ability to deliver higher future returns to shareholders.

WAMI's expertise in the LIC sector, a large retail distribution network, and investment team has the ability to provide significant tailwinds in addressing the large dislocation between the share price and the NTA.

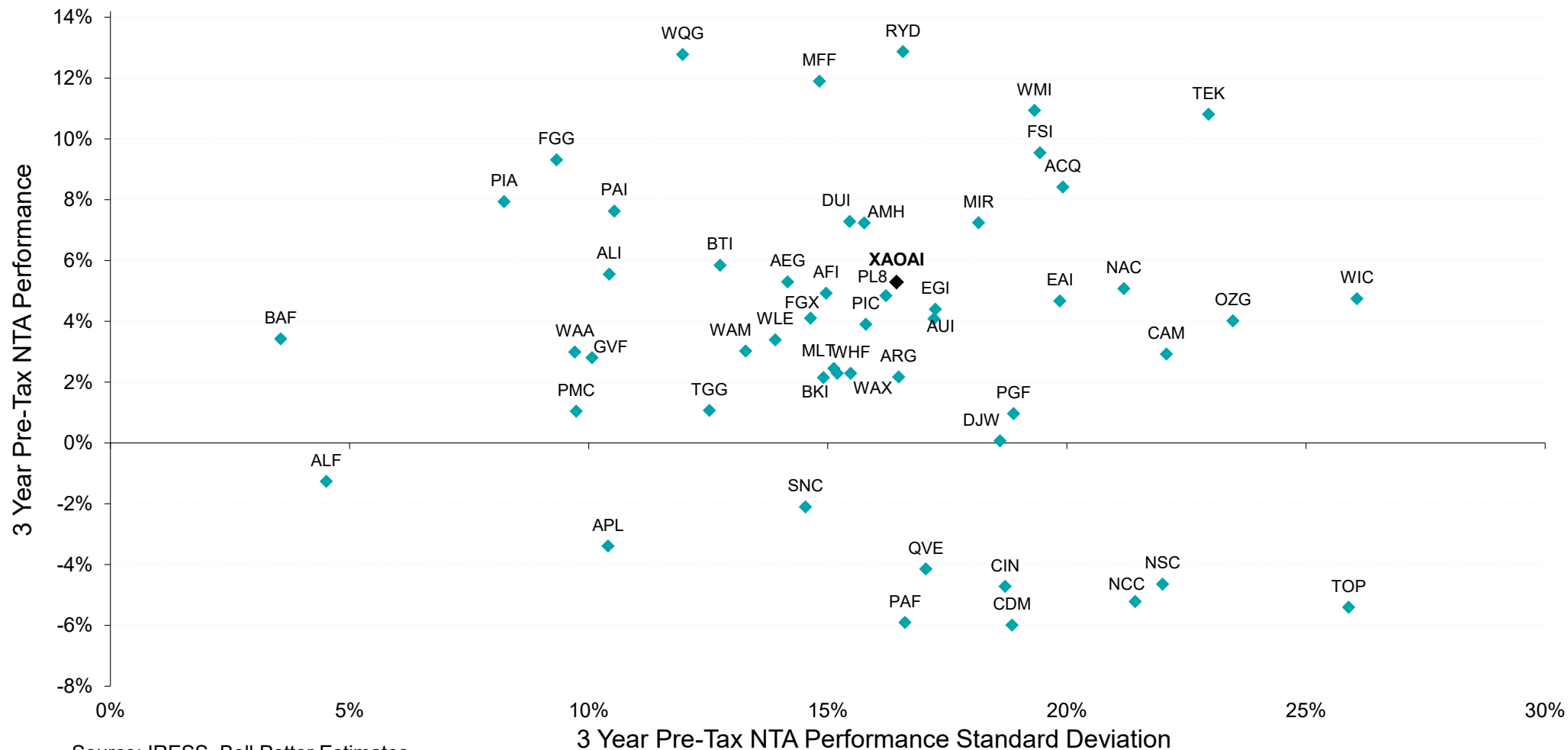

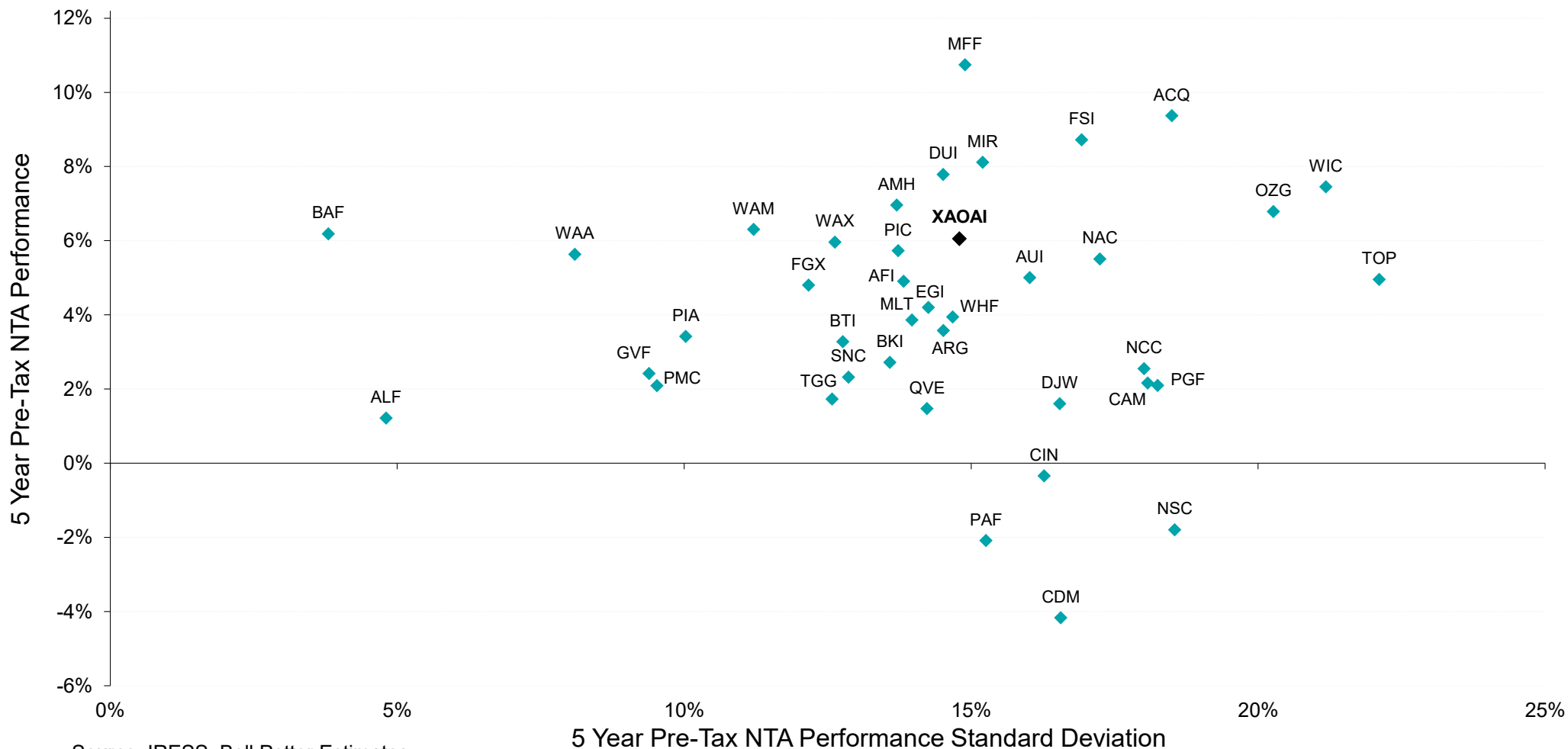
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

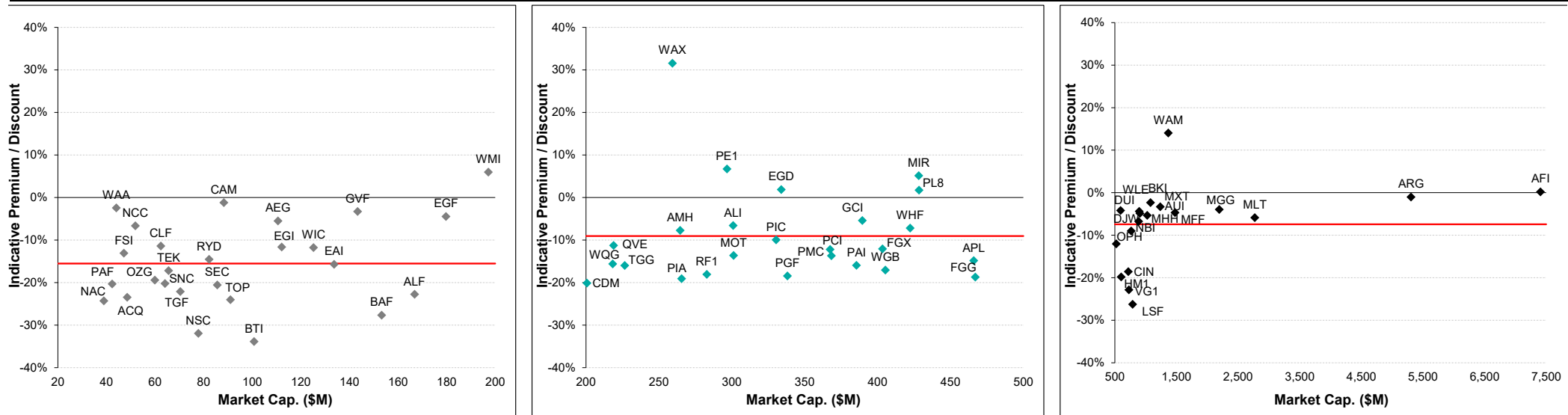

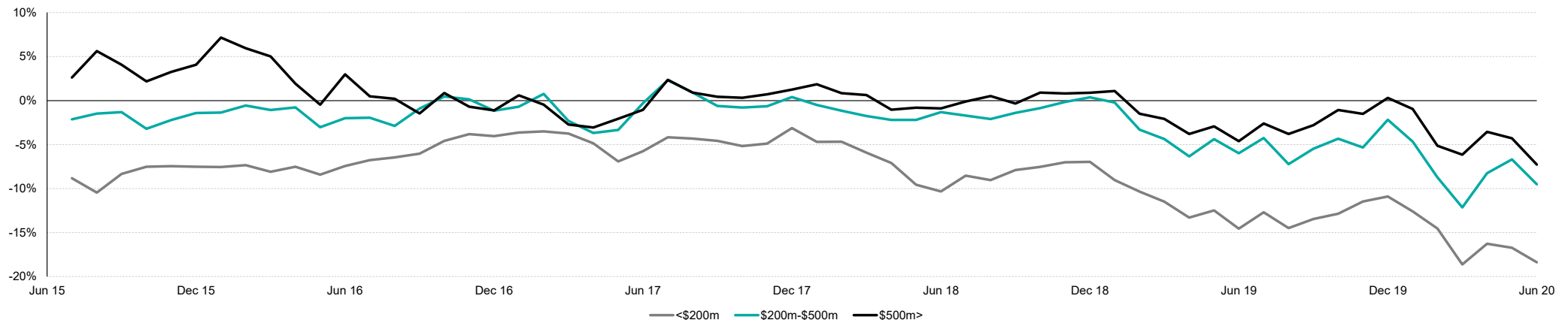


Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



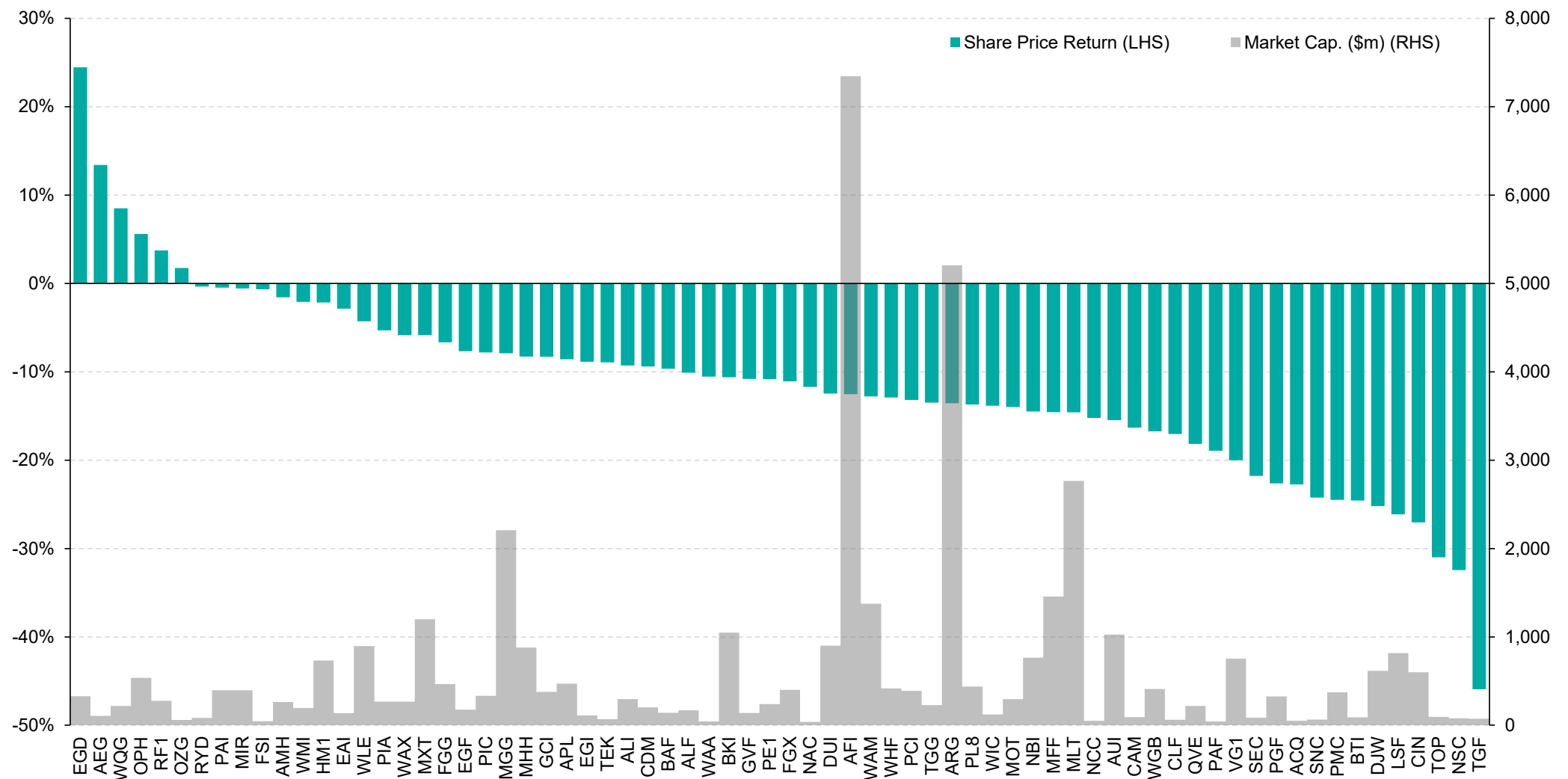
