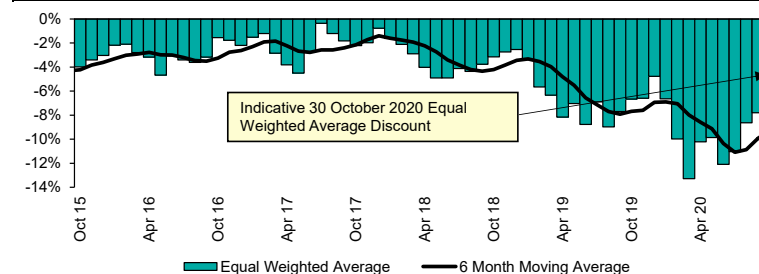
Amicable Outcome for CIE Shareholders

Contango Income Generator (CIE) was originally floated in 2015 with the objective of providing shareholders an increasing stream of dividends and capital growth over time. The domestically mandated fund, by policy, had aimed to return a minimum annualised yield of 6.5% of the company's net tangible assets per share. The investment portfolio had also historically provided exposure to the S&P/ASX 300 Ex-30. However a significant decline in interest rates and continued outperformance of growth stocks had rendered the then strategy unsustainable. CIE's mandate slowly disseminated to the point at which a Global Growth Long/Short strategy managed by **WCM Investment Management** was pitched to shareholders during an extraordinary general meeting in September earlier this year. With approximately 53% of the votes in favour of the resolution, and despite a split shareholder base, the company has since liquidated its old investment portfolio.

Following this chain of events **WAM Capital (WAM)** has announced and progressed with an unconditional off-market takeover bid for CIE by consideration of 1 WAM share for every 3 CIE shares, which is currently intended to close on Friday 13 November. Shareholders who no longer want to remain invested in the company or its revised strategy, can accept the offer which represents a 3.9% premium to CIE's 30 October share price and 3.3% to the 30 September pre-tax NTA. Those who accept will also be entitled to WAM's fully franked final dividend. However WCM is also a world class fund manager, with a successful and proven track record across multiple investment strategies. As at 30 June 2020, WCM managed in excess of A\$85 billion on behalf of institutional and retail clients around the world. Their Australian LIC, **WCM Global Growth (WQG)** is a long only mandate with exceptional outperformance relative to the benchmark MSCI World Ex-Aus (A\$) Index. An amicable outcome for the split shareholder base, however it remains clear that mandates are sticky must be stringently adhered to.

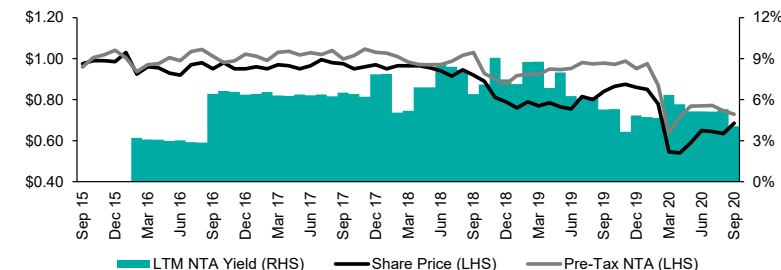

Figure 1 - Average Premium/Discount



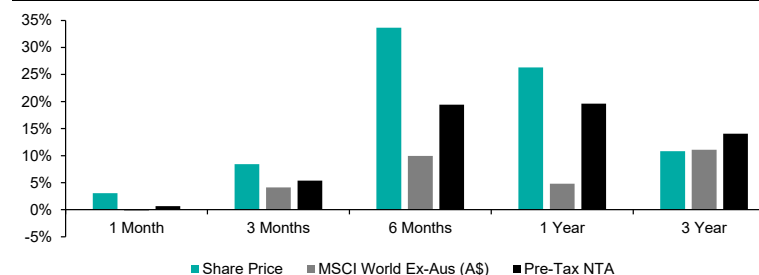

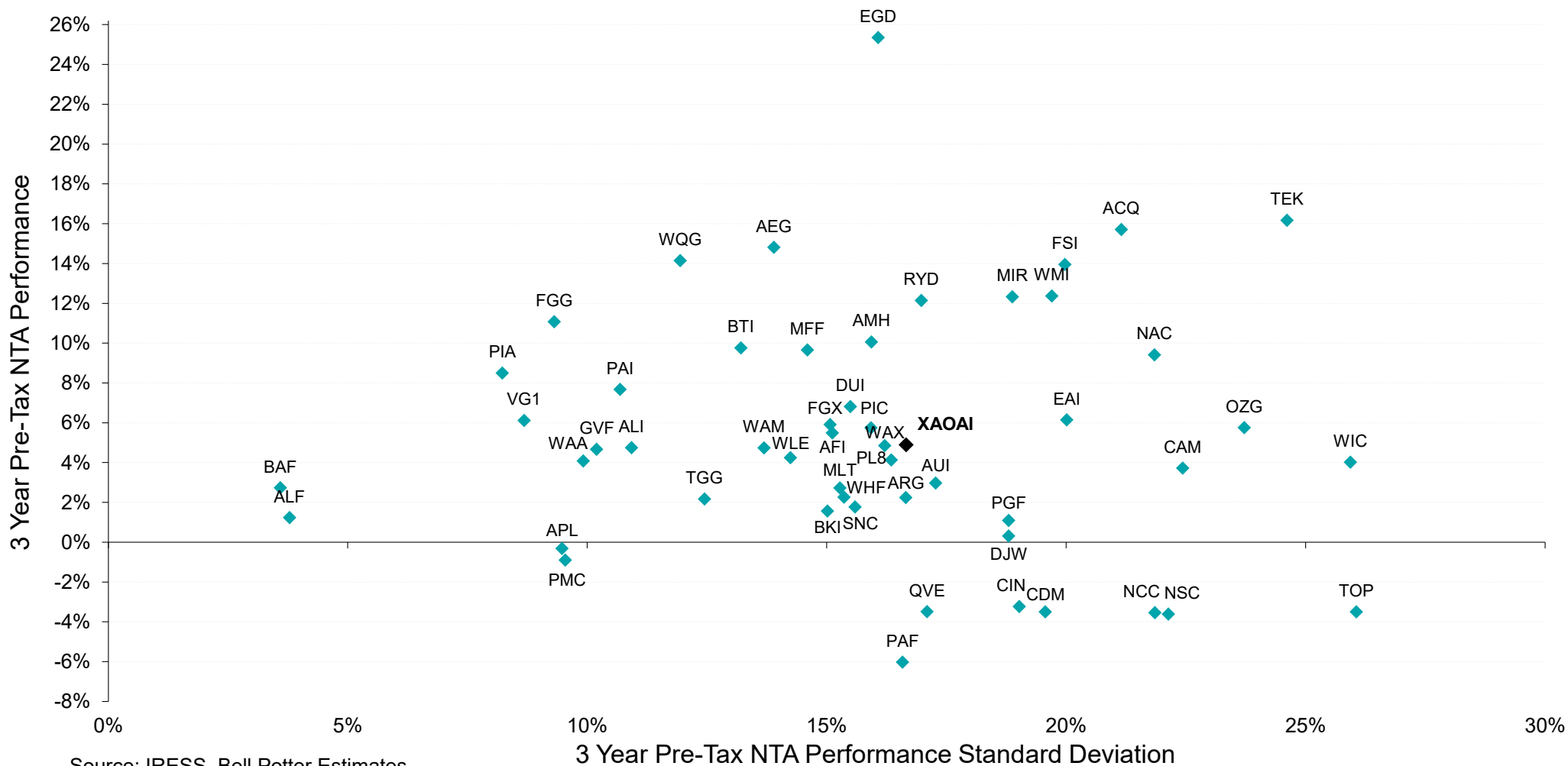

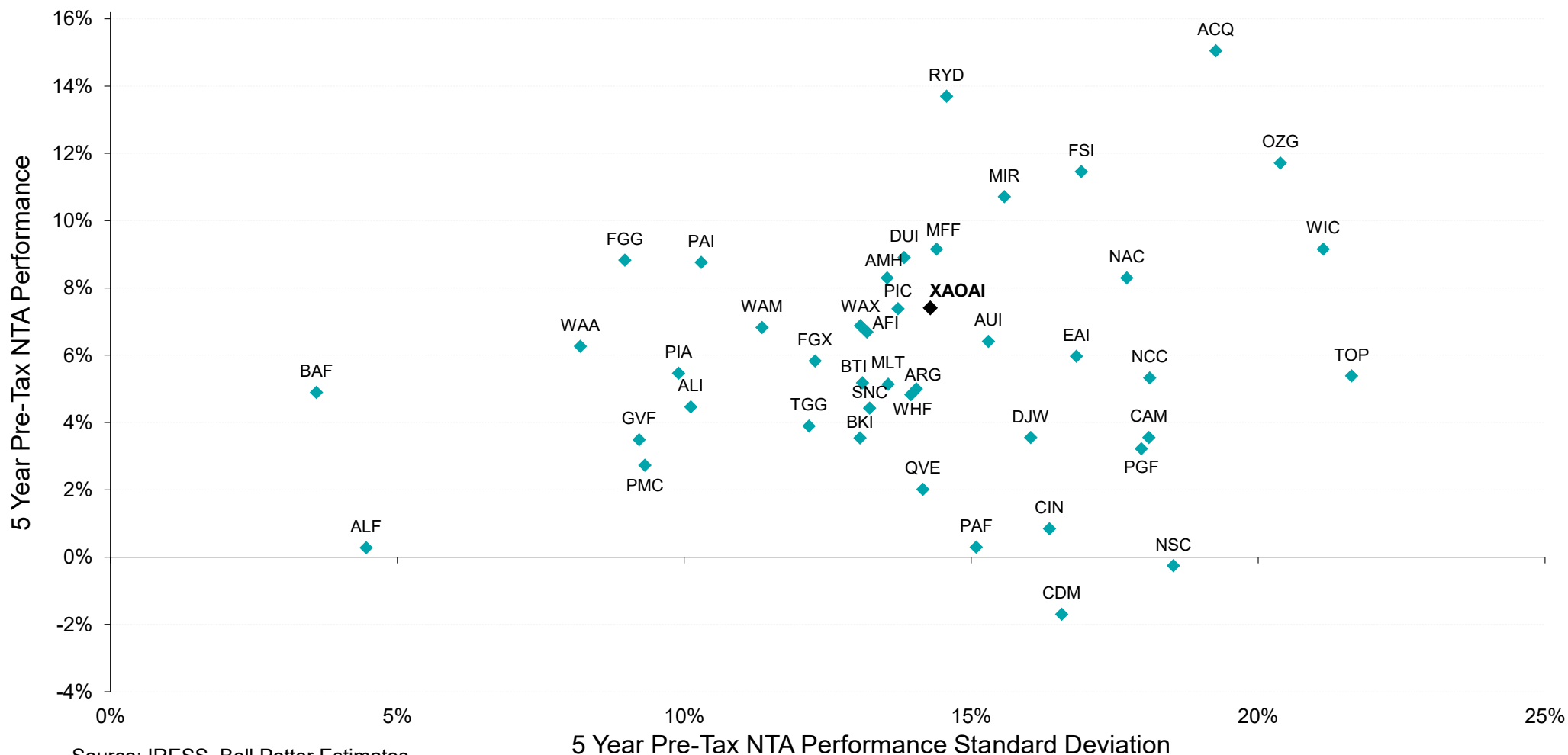
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

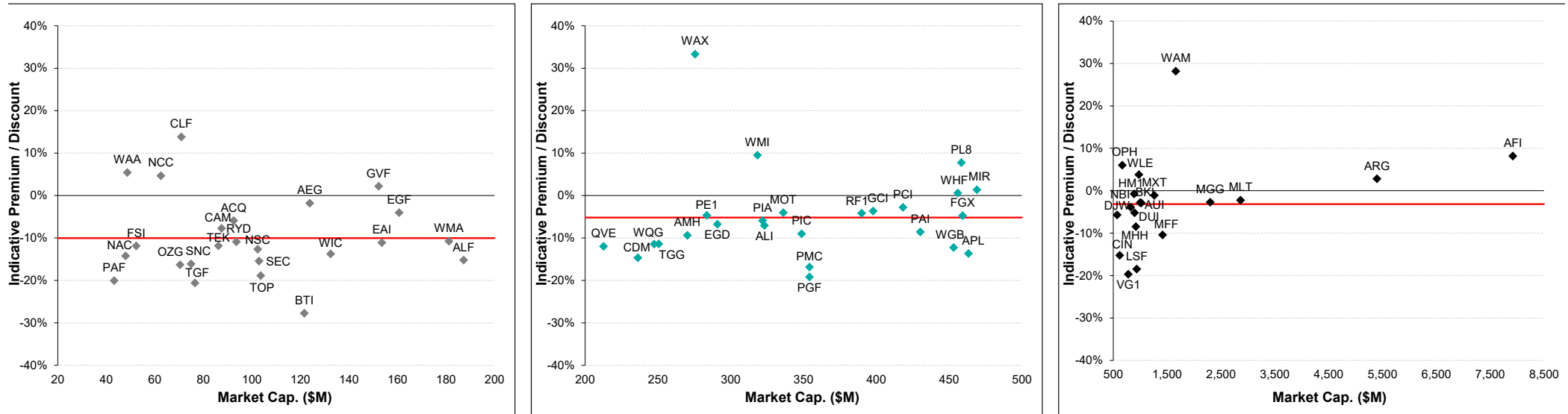

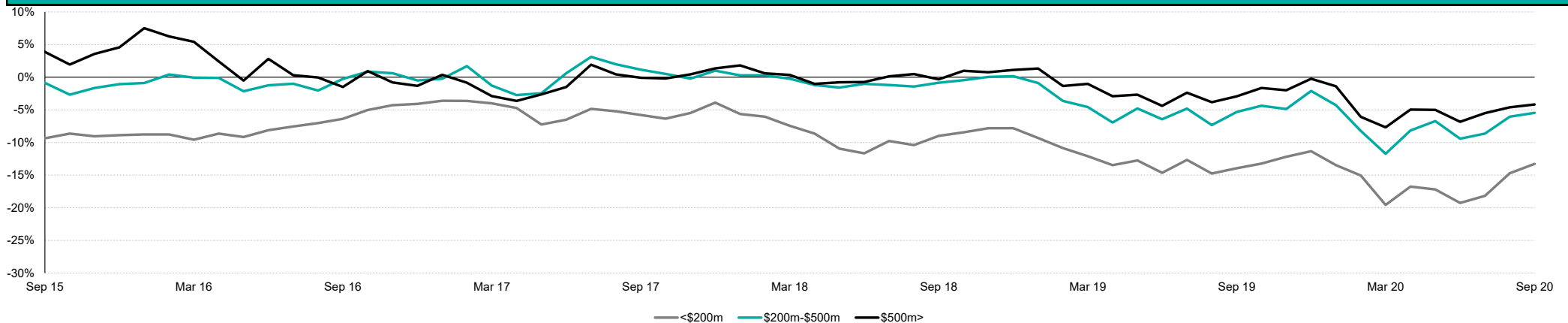


Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



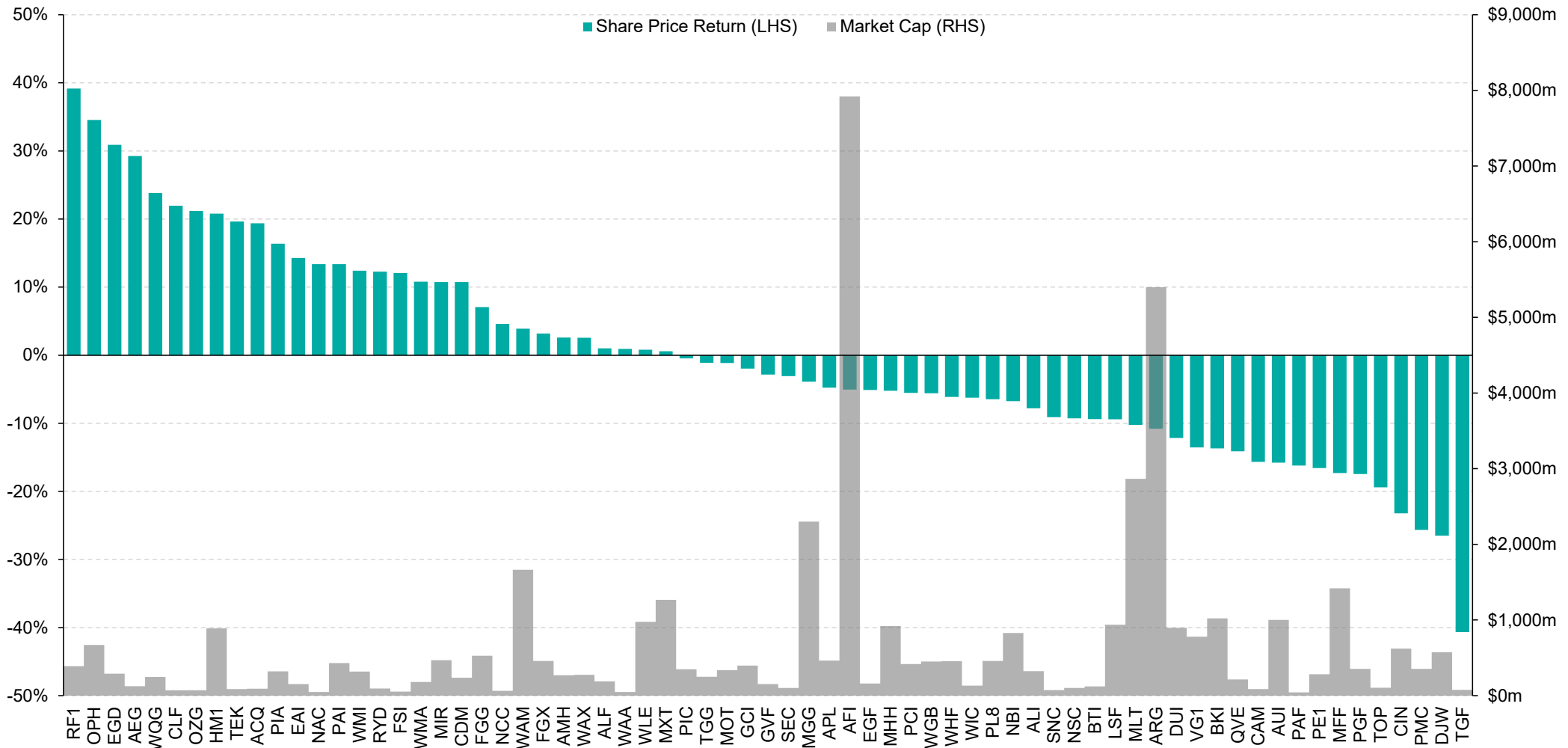
